These shares are in addition to the shares of common stock registered pursuant to the registration statement on Form S-8, File No. 333-168406 which we filed with the Securities and Exchange Commission on July 30, 2010, and the registrations statements on Form S-8, File No. 333-160230 and File No. 333-141404, which we filed with the Securities and Exchange Commission on June 25, 2009 and March 19, 2007, respectively. The reservation of these 2,300,000 additional shares for issuance pursuant to the Plans was approved by our board of directors on May 22, 2013 and by our stockholders on May 29, 2013.
