(LS), the general partner of Special Situations Life Sciences Fund, L.P. (Life Sciences). AWM serves as the investment adviser to SSFQP, SSPE, and Life Sciences. (SSFQP, SSPE, and Life Sciences will hereafter be referred to as, the Funds). The principal business of each Fund is to invest in equity and equity-related securities and other securities of any kind or nature.
