Item 8.01 Other Events.

On March 4, 2016, we completed the offering and sale (the **Offering**) of an aggregate of 9,000,000 shares of our common stock and warrants to purchase an aggregate of 4,500,000 shares of our common stock, for aggregate gross proceeds of \$2,970,000. Each share of common stock we sold in the offering was accompanied by one-half of a warrant to purchase one share of common stock at an exercise price of \$0.50 per share for a period of two years from the date of issuance. Each share of common stock and accompanying one-half of one warrant was sold at a price of \$0.33.

These securities have been registered under the Securities Act of 1933 pursuant to our registration statement on Form S-1, as amended (No. 333-209124), which was declared effective by the Securities and Exchange Commission on February 11, 2016.

Also on March 4, 2016, we used the proceeds of the Offering to repay loans in the aggregate principal amounts of \$1,500,000 (originally from Neil Rogers and Turnstone Capital Inc.).
