Explanatory Note

On October 24, 2007, pursuant to the Agreement and Plan of Merger, dated as of July 3, 2007, among Hilton Hotels Corporation (the "Company"), BH Hotels LLC, a Delaware limited liability company ("Parent"), and BH Hotels Acquisition Inc., a Delaware corporation ("Merger Sub"), Merger Sub merged with and into the Company (the "Merger"), with the Company being the surviving entity and becoming a wholly-owned subsidiary of Parent. As a result, the Company has terminated all offerings of its Common Stock, \$2.50 par value per share ("Common Stock") pursuant to its existing registration statements, including the Company's Registration Statement on Form S-8 (File No. 333-72906) (the "Registration Statement"). In accordance with an undertaking made by the Company in its Registration Statement to remove from registration, by means of a post-effective amendment, any shares of the Company's Common Stock which remain unsold at the termination of the offering, the Company hereby removes from registration all shares of its Common Stock under the Registration Statement which remained unsold as of the effective time of the Merger.
