On September 11, 2003, Exact Sciences Corporation (the Company) filed a registration statement on Form S-3 (Registration No. 333-108679), as amended to date (the Registration Statement), to register \$100,000,000 in aggregate maximum offering price of the Company's common stock, preferred stock, debt securities and warrants to be offered by the Company from time to time.
