This was as a result of a share transfer (the "Transfer") of 108,576 shares to the Revocable Trust and 50,000 shares to S Griffin & Kulpik TTEE, Griffin Family Trust, U/A DTD 02/10/2006 on June 16, 2016 by William F. Griffin, Jr. GRAT DTD 03/29/14 (the "GRAT"), of which the Reporting Person is the trustee. Pursuant to the Transfer, the GRAT no longer owns any shares of the Issuer's common stock, while the amount of shares owned by the Revocable Trust increased from 347,574 shares to 456,150 shares.
