**PEACE ARCH ENTERTAINMENT GROUP INC. ANNOUNCES SETTLEMENT OF SHARE ISSUE  
OBLIGATION**

**TORONTO, ONT.** Peace Arch Entertainment Group Inc. (AMEX and TSX: PAE ), a diversified Canadian entertainment company, today announced that it has completed an arrangement by which the Company has settled all of its obligations to issue shares to Fremantlemedia Enterprises Ltd. ("Fremantle") and Comerica Bank-California ("Comerica").

This marks the final step in the process of settling the Company's historic debts and obligations to both Fremantle and Comerica. As of January 30, 2003, the Company owed Fremantle CDN\$7,580,000 and US\$1,075,000 to Comerica.

Peace Arch Entertainment Group Inc. has made arrangements for the immediate issuance of 3,153,814 common shares into escrow in satisfaction of its obligations to Fremantle as well as the issuance of 336,000 common shares into

escrow in satisfaction of its obligations to Comerica.

### GENERAL INSTRUCTIONS

#### A.

##### **Rule as to Use of Form 6-K,**

This form shall be used by foreign private issuers which are required to furnish reports pursuant to Rule 13a-16 or 15d-16 under the Securities Exchange Act of 1934.

#### B.

##### **Information and Document required to be Furnished,**

Subject to General Instruction D herein, an issuer furnishing a report on this form shall furnish whatever information, not required to be furnished on Form 40-F or previously furnished, such issuer (I) makes or is required to make public pursuant to the law of the jurisdiction of its domicile or in which it is incorporated or organized, or (ii) files or is required to file with a stock exchange on which its securities are traded and which was made public by that exchange, or (iii) distributes or is required to distribute to its security holders.

At least one of the copies deposited with the Commission and one filed with each such exchange shall be manually signed. Unsigned copies shall be conformed.
