In connection with the vesting of shares of restricted stock units pursuant to the Antero Resources Corporation Long-Term Incentive Plan, (1) the Issuer withheld shares that would otherwise have been issued to the Reporting Person to satisfy its tax withholding obligations. The number of shares withheld was determined based on the closing price per share on April 15, 2019.

(2) Includes 38,462 shares of common stock subject to previously granted restricted stock unit awards that remain subject to vesting.

Includes 3,848,997 shares of common stock held by Canton Investment Holdings LLC ("Canton"). The Reporting Person is the managing (3) member and 50% owner of Canton.
