Shares of deferred stock not credited to the stock unit account because of termination as a director before the end of the director's term are forfeited.

- (3) Includes 11,844 shares of deferred common stock deliverable under the Monsanto Company Non-Employee Director Equity Incentive Compensation Plan; 490 shares of common stock issued as dividends with respect to such shares; and 9,546 shares of common stock owned directly by the Reporting Person.
