- (1) Option exercisable in three increments with 50% vesting on May 2, 2013, 25% vesting on May 2, 2014, and the remaining 25% vesting on May 2, 2015.
- (2) Award of Restricted Stock Units (RSUs) granted under The Allstate Corporation 2009 Equity Incentive Plan. Each RSU represents the right to receive, without the payment of any consideration, one share of Allstate common stock on the day following the last day of the period of restriction (the conversion date). The period of restriction shall begin on May 2, 2011, and 50% of the total number of RSUs will convert on May 2, 2013, 25% will convert on May 2, 2014, and the remaining 25% will convert on May 2, 2015.
