- (3) The reporting person received a grant of 3,600 restricted stock units that vest in four equal annual installments beginning May 14, 2011. Vested shares may be distributed to the Reporting Person only after that person's termination of employment with TFS Financial Corporation.
- (4) The reporting person received a grant of 50,000 stock options that vest in three equal annual installments beginning August 11, 2011.
- (5) The reporting person received a grant of 31,500 stock options that vest in three equal annual installments beginning May 14, 2011.
- (6) The reporting person received a grant of 36,900 stock options on December 19, 2011 that vest in three equal annual installments beginning December 15, 2012.
- (7) The reporting person was granted 5,500 Restricted Stock Units ("RSUs") on December 19, 2011. These RSUs vest in three equal annual installments beginning 12/15/2012.
