- (1) On February 22, 2012 the Issuer granted the Reporting Person a restricted stock award of 10,332 restricted shares of First Midwest Bancorp, Inc. common stock under the First Midwest Bancorp, Inc. Omnibus Stock Incentive Plan which were scheduled to vest in two equal annual installments on the second and third anniversary of the date of grant. On February 22, 2014, 5,166 shares of the originally granted restricted stock award vested, of which 2,650 shares were withheld in order to satisfy the Reporting Person's tax withholding obligations.
- (2) On February 23, 2011 the Issuer granted the Reporting Person a restricted stock award of 8,971 restricted shares of First Midwest Bancorp, Inc. Common stock under the First Midwest Bancorp, Inc. Omnibus Stock Incentive Plan which were scheduled to vest in two equal annual installments on the second and third anniversary of the date of grant. On February 23, 2014, the remaining 4,485 shares of the originally granted restricted stock award vested, of which 2,067 shares were withheld in order to satisfy the Reporting Person's tax withholding obligations.
