- (1) The restricted stock units were earned based on Company performance during fiscal 2016 and vested in one installment based on continued employment through the end of fiscal 2018; the reporting person elected to defer the receipt of a portion of the underlying shares.
- (2) Includes 4.0142 shares acquired under a dividend reinvestment plan.
- (3) Shares were withheld to cover tax withholding upon the vesting of the restricted stock units.
