- (1) On January 2, 2013, the Issuer entered into an agreement with Robert J. Mueller (the "Reporting Person") whereby the Reporting Person was granted a restricted stock award of 950 shares of Class A Common Stock pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan (the "Restricted Stock Award Plan").
- (2) This figure includes 4,700 restricted shares of Class A Common Stock issued pursuant to the Restricted Stock Award Plan. On December 28, 2012, restrictions applicable to a previously reported grant of 900 shares of Class A Common Stock lapsed, resulting in the reporting person becoming fully vested in such shares. This resulted in no change in the number of shares beneficially owned by the Reporting Person.
- (3) The Reporting Person is the direct beneficial owner of 8,000 shares of Class A Common Stock, including the 4,700 restricted shares referenced in Footnote (2). Additionally, he is the indirect beneficial owner of 31,950 shares of Class A Common Stock owned of record by the Robert J. Mueller IRA Rollover Account, for the benefit of the Reporting Person.
