(1) On March 1, 2013, the reporting person was granted 25,000 restricted stock units under the Silgan Holdings Inc. 2004 Stock Incentive Plan, as amended, subject to the satisfaction of certain performance criteria for the Issuer's 2013 fiscal year. The performance criteria for the Issuer's 2013 fiscal year was determined to have been met upon the finalization of the Issuer's audited financial statements for 2013. Accordingly, these restricted stock units are no longer subject to cancellation. These restricted stock units will vest all at once on March 1, 2019 and will be settled in shares of Common Stock on a 1-for-1 basis.

(2) These securities are restricted stock units that were granted on March 1, 2014 under the Silgan Holdings Inc. 2004 Stock Incentive Plan, as amended. These restricted stock units vest ratably over a 5 year period beginning March 1, 2015 and will be settled in shares of Common Stock on a 1-for-1 basis upon vesting.

(3) This amount includes 92,360 restricted stock units that are not yet vested that have been granted under the Silgan Holdings Inc. 2004 Stock Incentive Plan, as amended. Upon vesting, these restricted stock units will be settled in shares of Common Stock on a 1-for-1 basis.
