ITEM 5.07. Submission of Matters to a Vote of Security Holders

The Emclaire Financial Corp. (the Corporation) Annual Meeting of Shareholders was held on April 28, 2010. At the annual meeting, 1,087,055 shares of common stock, or 75.95% of the 1,431,404 shares of common stock outstanding and entitled to vote at the annual meeting, were voted in person or by proxy.

Set forth below are the matters which were acted upon by the Corporation's shareholders at the annual meeting:

- 1. Election of two (2) directors to serve for three-year terms and until their successors are duly elected and qualified;
- 2. Ratification of the selection of Crowe Horwath LLP, Certified Public Accountants, as the independent auditors of the Corporation for the fiscal year ending December 31, 2010; and
- 3. Approval, on a non-binding advisory basis, of the compensation of the Corporation's named executive officers as described in the proxy statement for the annual meeting.

As to proposal number one, the following directors were elected for a three year term expiring in 2013:

In addition to the above listed individuals, the following persons continue to serve as directors: Ronald L. Ashbaugh, George W. Freeman, William C. Marsh, Brian M. McCarrier, James M. Crooks, Robert L. Hunter and John B. Mason.

Proposal number two, the recommendation of the Board of Directors to ratify the appointment of Crowe Horwath, LLP as the Corporation's independent auditors, was approved with 1,066,687 shares in favor, 12,545 shares against and 7,823 shares abstained.

Proposal three, the recommendation of the Board of Directors to approve the compensation of certain of the Corporation's executive officers, was approved with 849,254 shares in favor, 201,669 shares against, 36,130 shares abstained and 2 shares broker non-votes.
