- (1) On September 12, 2012, 5,715 shares of United Natural Foods, Inc. (the "Company") restricted stock units vested. The Company retained 2,412 shares on that date to satisfy certain tax withholding obligations in connection with the vesting of such shares.
Includes 466 shares of common stock allocated to the reporting person under the United Natural Foods, Inc. Employee Stock Ownership Plan as well as 1,500 shares held by a daughter(1) of the reporting person, 1,500 shares held by a daughter(2) of the reporting person, and 1,500 shares held by the brother of the reporting person, as custodian for a daughter(3) of the reporting person as of September 13, 2012.
