(1) 401(k) Plan: This amount includes shares and dividends acquired during the fiscal year pursuant to the H.B. Fuller Company Thrift Plan.
(2) 2000 Stock Incentive Plan: This option vests in four equal annual installments beginning on January 17, 2003.
(3) 2000 Stock Incentive Plan: This option vests in four equal annual installments beginning on December 9, 2003.
(4) Deferred Compensation Plan: These units convert into shares of common stock on a 1-for-1 basis.
