- (1) 401(k) Plan: This amount includes shares and dividends acquired during the fiscal year pursuant to the H.B. Fuller Company Thrift Plan.
2000 Stock Incentive Plan: Amount includes 9,423 restricted shares that were awarded pursuant to H.B. Fuller Company's 2000 Stock Incentive Plan: 893 restricted shares vest in two equal annual installments beginning April 15, 2007; 4,474 restricted shares vest effective December 2, 2007; and 4,056 restricted shares vest effective December 1, 2008.
