50% of the restricted stock units vest in four equal annual installments with the vesting dates beginning April 4, 2012 and ending April 4, 2015. The remaining 50% of the restricted stock units vest in four equal installments on each date in 2012, 2013, 2014 and 2015 when the compensation committee determines if certain performance criteria for each of the fiscal years 2011, 2012, 2013 and 2014 are satisfied, which date shall be not later than the earlier of (i) 30 days following the completion of the annual audited financials and (ii) April 30th of the year following the performance year.
