- (1) The sales reported on This Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the reporting person on 11/4/2011. The price reported in Column 4 is a weighted average price. Lee Partners, L.P.) criteria. As of the date of this filing, the performance criteria has been met with respect to an aggregate of 546,683 shares of Common Stock subject to this option award, with 328,048 of such shares vested and the remaining 218,635 of such shares eligible to vest in two equal annual installments beginning on 2/23/2013.
