- Each restricted stock unit ("RSU") is granted pursuant to the 2011 Equity Incentive Plan, and represents a contingent right to receive one share of Common Stock of the Issuer. The shares subject to the RSU award vest over a four-year period, with 12.5% of the RSU's
- (1) (rounded down to the nearest whole share) vesting on November 15, 2013 (the "VCD"); thereafter, 6.25% of the RSU's (rounded down to the nearest whole share, except for the last vesting installment) shall vest on each quarterly anniversary of the VCD, provided that the Reporting Person provides Continuous Service, as defined in the 2011 Equity Incentive Plan.
 - (2) Issued pursuant to the Issuer's 2011 Equity Incentive Plan.
 - (3) The shares subject to the stock option vest over a four-year period commencing April 10, 2013, with 12.5% of the shares vesting on October 10, 2013; thereafter, the balance of the shares subject to the option vests in a series of 42 equal successive monthly installments for so long as the Reporting Person provides Continuous Service, as defined in the 2011 Equity Incentive Plan.
