#### Item 1.01 Entry into a Material Definitive Agreement

On November 30, 2004, New Century Credit Corporation, a wholly-owned direct subsidiary of New Century Financial Corporation (NCFC), NC Capital Corporation (NCCC), a wholly-owned indirect subsidiary of NCFC, and NC Residual II Corporation, a wholly-owned direct subsidiary of NCCC, entered into a letter agreement with Bear Stearns Mortgage Capital Corporation (Bear Stearns), which extends the expiration date of the credit facility with Bear Stearns from November 30, 2004 until December 30, 2004.
