This statement relates to the beneficial ownership of securities of News Corporation (the Company or Issuer ) by the Murdoch Family Trust, the successor to the AE Harris Trust, Cruden Financial Services LLC (the trustee of the Murdoch Family Trust, Cruden Financial Services ), and by K. Rupert Murdoch, and further amends the previously filed statements on Schedule 13G. This statement is being filed to reflect the formation of the Murdoch Family Trust as successor to the AE Harris Trust. The Murdoch Family Trust holds all of the assets and has assumed all of the liabilities of the AE Harris Trust and acts through the same trustee as the AE Harris Trust, Cruden Financial Services.

All of the 297,280,548 Shares beneficially owned by Cruden Financial Services are also beneficially owned by the Murdoch Family Trust, successor to the AE Harris Trust. Cruden Financial Services has the power to vote and to dispose or direct the vote and disposition of the Shares owned by the Murdoch Family Trust. Cruden Financial Services, the sole trustee of the Murdoch Family Trust, is a Delaware limited liability company with six directors.

As of December 14, 2006, the Murdoch Family Trust, as successor to the AE Harris Trust, was the beneficial owner of 297,280,548 Shares, constituting approximately 30.1% of the total number of outstanding Shares at such date. The Murdoch Family Trust is a trust governed by Nevada law whose trustee is Cruden Financial Services. Cruden Financial Services, as sole trustee, has the power to vote and to dispose or direct the vote and disposition of the Shares owned by the Murdoch Family Trust.

As of December 14, 2006, K. Rupert Murdoch was the beneficial owner of 307,947,777 Shares, constituting approximately 31.2% of the total number of outstanding Shares at such date. Of the 307,947,777 Shares beneficially owned by K. Rupert Murdoch, 297,280,548 of such Shares are directly owned by the Murdoch Family Trust, the successor to the AE Harris Trust. Cruden Financial Services has the power to vote and to dispose or direct the vote and disposition of the Shares owned by the Murdoch Family Trust. As a result of Mr. Murdoch's ability to appoint certain members of the board of directors of Cruden Financial Services, the corporate trustee of the Murdoch Family Trust, Mr. Murdoch may be deemed the beneficial owner of the Shares beneficially owned by the Murdoch Family Trust. Mr. Murdoch, however, disclaims any beneficial ownership of such Shares.
