**Item 8.01. Other Events.**

Wal-Mart Stores, Inc. (the Company) and Deutsche Bank Securities Inc., J.P. Morgan Securities Inc. and Lehman Brothers Inc., acting for themselves and as representatives of the other several underwriters named in Schedule I to the Pricing Agreement (as defined below) (the Underwriters) have entered into a Pricing Agreement, dated March 29, 2007 (the Pricing Agreement), pursuant to which, subject to the satisfaction of the conditions set forth therein, the Company has agreed to sell to the Underwriters, and the Underwriters have agreed to purchase from the Company, \$500,000,000 aggregate principal amount of the Company's 5.000% Notes Due 2012 (the 2012 Notes), \$1,000,000,000 aggregate principal amount of the Company's 5.375% Notes Due 2017 (the 2017 Notes) and \$750,000,000 aggregate principal amount of the Company's 5.875% Notes Due 2027 (the 2027 Notes and, together with the 2012 Notes and the 2017 Notes, the Notes). The Pricing Agreement incorporates by reference the terms and conditions of an Underwriting Agreement, dated May 19, 2006 (the Underwriting Agreement), between the Company and, as to the issuance and sale of the Notes, the Underwriters.

The Company and the Underwriters expect to consummate the sale and purchase of the Notes pursuant to the Pricing Agreement on April 5, 2007. The 2012 Notes will be sold to the public at an aggregate issue price of 99.646% of the principal amount thereof (\$498,230,000). The 2017 Notes will be sold to the public at an issue price of 99.626% of the principal amount thereof (\$996,260,000). The 2027 Notes will be sold to the public at an issue price of 99.813% of the principal amount thereof (\$748,597,500). In total, the Notes will be sold to the public at an issue price of \$2,243,087,500. The net proceeds to the Company from the sale of the 2012 Notes, after the underwriting discount, but before transaction expenses of the sale of the 2012 Notes, will be \$496,480,000. The net proceeds to the Company from the sale of the 2017 Notes, after the underwriting discount, but before transaction expenses of the sale of the 2017 Notes, will be \$991,760,000. The net proceeds to the Company from the sale of the 2027 Notes, after the underwriting discount, but before transaction expenses of the sale of the 2027 Notes, will be \$742,035,000. In total, the net proceeds to the Company from the sale of the Notes, after the underwriting discount, but before transaction expenses of the sale of the Notes, will be an aggregate of \$2,230,275,000.

The 2012 Notes constitute the Company's newly created series of 5.000% Notes Due 2012 (the 2012 Series), the 2017 Notes constitute the Company's newly created series of 5.375% Notes Due 2017 (the 2017 Series) and the 2027 Notes constitute the Company's newly created series of 5.875% Notes Due 2027 (the 2027 Series and, together with the 2012 Series and the 2017 Series, the New Series). The Notes of each of the 2012 Series, the 2017 Series and the 2027 Series are senior, unsecured and unsubordinated debt securities of the Company and rank equally with each of the other New Series and all of the other senior, unsecured and unsubordinated debt obligations of the Company. The 2012 Series, the 2017 Series and the 2027 Series were created and established, and their terms and conditions were established, by action of the Company and an authorized officer of the Company pursuant to, and in accordance with, the terms of the Indenture, dated as of July 19, 2005, as supplemented (the Indenture), between the Company and The Bank of New York Trust Company, N.A., as trustee (the Trustee). The terms of the 2012 Notes, the 2017 Notes and the 2027 Notes are as set forth in the Indenture and in the forms of the Global Notes (referred to below) that will represent the Notes.

The material terms of the Notes are described in the prospectus supplement of the Company dated March 29, 2007, which relates to the offer and sale of the Notes (the Prospectus Supplement), and the Company's prospectus dated December 21, 2005, which prospectus relates to the offer and sale from time to time of an indeterminate amount of the Company's debt securities (the Prospectus). The Prospectus Supplement, together with the Prospectus, was filed by the Company with the Securities and Exchange Commission (the Commission) on April 2, 2007 pursuant to Rule 424(b)(2) under the U.S. Securities Act of 1933, as amended (the Securities Act), in connection with the offer and sale of the Notes. A Final Term Sheet, dated March 29, 2007, relating to the Notes was filed with the Commission pursuant to Rule 433 under the Securities Act on March 30, 2007.

The Notes will be delivered in book-entry form only. The 2012 Notes will be represented by a global note, in the original principal amount of \$500,000,000 (the 2012 Global Note). The 2017 Notes will be represented by two global notes, each in the original principal amount of \$500,000,000 (the 2017 Global Notes). The 2027 Notes will be represented by two global notes, one of which will be in the principal amount of \$500,000,000 and one of which will be in the principal amount of \$250,000,000 (the 2027 Global Notes) and, together with the 2012 Global Note and the 2017 Global Notes, the Global Notes). Each Global Note will be payable to Cede & Co., as nominee of The Depository Trust Company. The Global Notes will be executed by the Company and authenticated by the Trustee.

Filed as exhibits to this Current Report on Form 8-K are (i) the Pricing Agreement, (ii) the Underwriting Agreement, (iii) the Series Terms Certificate that relates to the 2012 Series, which was executed in accordance with the Indenture and which evidences the establishment of the terms and conditions of the 2012 Series in accordance with the Indenture, (iv) the Series Terms Certificate that relates to the 2017 Series, which was executed in accordance with the Indenture and which evidences the establishment of the terms and conditions of the 2017 Series in accordance with the Indenture, (v) the Series Terms Certificate that relates to the 2027 Series, which was executed in accordance with the Indenture and which evidences the establishment of the terms and conditions of the 2027 Series in accordance with the Indenture, (vi) the form of the 2012 Global Note, (vii) the form of the 2017 Global Notes, (viii) the form of the 2027 Global Notes and (ix) the opinion of Andrews Kurth LLP regarding the legality of the Notes.

The Company is offering and selling the Notes under the Company's Registration Statement on Form S-3 (File No. 333-130569), which registration statement relates to the offer and sale on a delayed basis from time to time of an indeterminate amount of the Company's debt securities. This Current Report on Form 8-K is being filed in connection with the offer and sale of the Notes as described herein and to file with the Commission in connection with the Registration Statement the documents and instruments attached hereto as exhibits.
