On August 18, 2008, CME Group Inc. (CME Group) jointly issued a press release with NYMEX Holdings, Inc. (NYMEX Holdings) announcing that preliminary results indicate the shareholders of both companies have approved the proposed merger of CME Group and NYMEX Holdings, based on a review of the proxies voted at today s special meetings by the parties respective proxy solicitors. In addition, preliminary results also show that NYMEX Class A members have voted to approve the amended and restated certificate of incorporation and bylaws of NYMEX, which approvals are a condition to the completion of the merger, in a separate member vote.
