**The Board of Directors recommends you vote FOR the following proposal:**

1. Proposal to amend Chipotle's Restated Certificate of Incorporation to (a) effect a reclassification of each outstanding share of Chipotle Class B common stock into one share of Chipotle Class A common stock and rename the Class A common stock as common stock; and (b) eliminate provisions relating to Chipotle's prior dual-class common stock structure, the ownership interest formerly held in Chipotle by McDonald's Corporation and other historical matters.
