- (a) The name of the issuer is Sonde Resources Corp. Inc. (the *Issuer* ).
- (b) The principal executive offices of the Issuer are located at Suite 3200, 500 4 Avenue SW, Calgary, Alberta, Canada, T2P 2V6.

- (a) This Statement is being filed by (i) West Coast Opportunity Fund, LLC, a Delaware limited liability company (the *Fund* ), (ii) West Coast Asset Management, Inc., a California corporation (the *Managing Member* ), which serves as the managing member of the Fund, (iii) R. Atticus Lowe, a United States Citizen ( *Lowe* ); (iv) Lance W. Helfert, a United States Citizen ( *Helfert* ); and (v) Paul J. Orfalea, a United States Citizen ( *Orfalea* ), and together with Lowe and Helfert, the *Principals* , and all of the foregoing, collectively, the *Filers* ). The Managing Member provides investment management services to the Fund (a private investment vehicle) and separately managed accounts, some of which are affiliated with the Filers (such accounts, the *Accounts* ). The Fund and the Accounts directly own all of the shares reported in this Statement (other than the 1,000 shares owned directly by Helfert and the 357 shares owned directly by Orfalea). The Principals and the Managing Member may be deemed to share with the Fund and the Accounts (and not with any third party) voting and/or dispositive power with respect to such shares. Each Filer disclaims beneficial ownership with respect to any shares other than those owned directly by such Filer.
- (b) The principal business office of the Filers is 1205 Coast Village Road, Montecito, California 93108.
- (c) For citizenship information see Item 4 of the cover page of each Filer.
- (d) This Statement relates to the Common Stock, no par value, of the Issuer (the *Common Stock* ).
