**Exelon to acquire Constellation Energy Group**

**Message from John W. Rowe**

**Thursday, April 28, 2011**

Dear colleagues,

I am writing to share with you some exciting and important news: Exelon has agreed to acquire Constellation Energy Group, with the combined company poised to become the largest competitive integrated utility in the nation. More information will be shared with you in the days, weeks, and months ahead.

This is the merger that we at Exelon have been working and waiting for – one that provides value from the start for all parties involved: companies, employees, shareholders and customers. In many ways, it mirrors the Unicom-PECO merger in its potential to be an industry-changing transaction. In other respects, it is quite different.

One of those differences is a very personal one for me: our agreement with Constellation signals the concluding months of my tenure with Exelon. I plan to retire upon the closing of the merger, in early 2012.

Upon closing, Chris Crane will become president and chief executive officer of the combined company, with current Constellation CEO Mayo Shattuck serving as executive chairman.

This is not a transition that I approach lightly. Exelon represents the culmination of all that I have learned in my 27 years as a CEO running utilities. Building Exelon is my proudest achievement. I am delighted to leave it with a transaction that adds genuine value, and I expect to stay invested in it for a long time.

Leaving Exelon in the strong hands of Mayo Shattuck and Chris Crane is something I do with great pleasure and the utmost confidence.

And while this is an exciting time for Exelon, it is also one that I know involves uncertainty for employees on both sides of the transaction. That is in some ways an unavoidable part of the change associated with a merger, but I commit to you that we will do our best to keep you informed as regularly as we can.

Ron DeGregorio has been named our chief integration officer for the merger he will be forming a cross-functional team representing key business units across Exelon and Constellation to manage the transition, and he will provide updates on our progress on a regular basis.

Know that I am grateful for your support as we look to the future. Chris and I are counting on you to do everything you can to ensure that we continue to reach for our Vision of being the best group of electric generation and electric and gas delivery companies in the United States.

The company will be the second largest regulated distributor of electricity and gas, with 6.6 million customers in Maryland, Illinois and Pennsylvania
