## Item 7.01 Regulation FD Disclosure

On August 21, 2012, Fifth Third Bancorp (Fifth Third) issued a news release announcing (1) that the Board of Governors of the Federal Reserve System did not object to its capital plan submitted under the Comprehensive Capital & Analysis Review (CCAR) process, (2) that its Board of Directors have authorized Fifth Third to repurchase up to 100 million shares of Fifth Third common stock in the open market or in privately negotiated transactions, (3) that as part of the authorization to acquire its shares, Fifth Third expects to enter into a contract with a counterparty in the near term to repurchase up to \$350 million of its shares of common stock, and (4) that its Board of Directors may consider a possible dividend increase at its next regularly scheduled Board meeting in September. A copy of the news release is attached hereto as Exhibit 99.1.

The information included in this Item 7.01 and in Exhibit 99.1 shall not be deemed filed for purposes of Section 18 of the Securities Exchange Act of 1934, as amended, nor shall it be deemed incorporated by reference in any filing under the Securities Act of 1933, as amended, except as shall be expressly set forth by specific reference.

### **Item 8.01 Other Events**

On August 21, 2012, Fifth Third s Board of Directors authorized Fifth Third to repurchase up to 100 million shares of its outstanding common stock in the open market or in privately negotiated transactions, and to utilize any derivative or similar instrument to effect share repurchase transactions (including without limitation, accelerated share repurchase contracts, equity forward transactions, equity option transactions, equity swap transactions, cap transactions, collar transactions or other similar transactions or any combination of the foregoing transactions). This share repurchase authorization replaces the Board s previous authorization pursuant to which approximately 14 million shares remained available for repurchase by Fifth Third. As part of this authorization to acquire its shares, Fifth Third announced that it expects to enter into a contract shortly with a counterparty to repurchase up to \$350 million of its shares of common stock.

Fifth Third also announced that the Board of Governors of the Federal Reserve System did not object to its capital plan submitted under the CCAR process and its Board of Directors may consider a possible dividend increase at its next regularly scheduled Board meeting in September.
