**Item 8.01 Other Events.**

On November 28, 2012, Ally Financial Inc. ( "Ally" ) entered into an Underwriting Agreement incorporating Ally's Underwriting Agreement Standard Provisions (Debt Securities) (together, the "Underwriting Agreement" ) with Barclays Capital Inc., Citigroup Global Markets Inc., Deutsche Bank Securities Inc. and Goldman, Sachs & Co., as representatives of the several Underwriters named therein (the "Underwriters" ), pursuant to which Ally agreed to sell to the Underwriters \$500,000,000 aggregate principal amount of 3.125% Senior Guaranteed Notes due 2016 (the "Notes" ). The Notes will be guaranteed by Ally US LLC, IB Finance Holding Company, LLC and GMAC Continental Corporation, each a subsidiary of Ally, on an unsubordinated basis (the "Guarantees" and, together with the Notes, the "Securities" ). The Securities were registered pursuant to Ally's shelf registration statement on Form S-3 (File No. 333-171519), which became automatically effective on January 3, 2011.

The Underwriting Agreement contains customary representations, warranties and covenants of the Company, conditions to closing, indemnification obligations of the Company and the Underwriters, and termination and other customary provisions.

The foregoing description of the Underwriting Agreement does not purport to be complete and is qualified in its entirety by reference to the full text of the document which is attached as Exhibit 1.1 to this Current Report on Form 8-K and incorporated by reference herein.
