Item 1.01 Entry into a Material Definitive Agreement.

On March 6, 2017, Hannon Armstrong Sustainable Infrastructure Capital, Inc. (the Company) entered into an underwriting agreement with Merrill Lynch, Pierce, Fenner & Smith Incorporated, Morgan Stanley & Co. LLC and Deutsche Bank Securities Inc. as representatives of the several underwriters named in Schedule A thereto, in connection with the offer and sale by the Company to the underwriters of 3,450,000 shares of its common stock, par value \$0.01 per share (including 450,000 shares pursuant to an option to purchase additional shares which was exercised in full), at a price of \$18.73 per share. The Company received aggregate net proceeds from the offering of approximately \$64.0 million after deducting offering expenses. The shares of the Company's common stock are being offered and sold under a prospectus supplement and related prospectus filed with the U.S. Securities and Exchange Commission pursuant to a shelf registration statement on Form S-3 (File Nos. 333-215229). The offering closed on March 10, 2017. A copy of the underwriting agreement is attached as Exhibit 1.1 to this Current Report on Form 8-K and is incorporated herein by reference.
