- (1) Each share of Series C-3 Preferred Stock will convert automatically into 0.25 shares of Common Stock immediately prior to the closing of the Issuer's initial public offering.

- Does not reflect the conversion of the Series C-3 Preferred Stock into Common Stock. The shares are held as follows: 9,525,412 by MPM BioVentures II-QP, L.P. ("BV II QP"), 1,051,305 by MPM BioVentures II, L.P. ("BV II"), 219,315 by MPM Asset Management Investors 2000B LLC ("AM 2000B") and 3,353,420 by MPM BioVentures GmbH & Co. Parallel-Beteiligungs KG ("BV KG").
- (2) MPM Asset Management II, L.P. ("AM II GP") and MPM Asset Management II LLC ("AM II LLC") are the direct and indirect general partners of BV II QP, BV II and BV KG. Luke Evnin, Ansbert Gadicke, Nicholas Galakatos, Michael Steinmetz and Kurt Wheeler are the members of AM II LLC and AM 2000B. Each member of the group disclaims beneficial ownership of the securities except to the extent of its pecuniary interest therein.
 - (3) Immediately.
 - (4) Calculated based on an assumed exercise price of \$5.50 per share. The number of shares issuable upon the exercise of this warrant may be calculated by dividing an aggregate of \$232,237.50 by the exercise price per share. The exercise price will be set at the price per share paid by the investors in the issuer's initial public offering.
 - (5) The shares are held as follows: 28,427 by BV II QP, 3,137 by BV II, 654 by AM 2000B and 10,007 by BV KG.
 - (6) On June 13, 2005, the Reporting Persons mistakenly filed a Form 3 reporting warrants for an aggregate of 25,804 shares of Common Stock. As of June 28, 2005, the Reporting Persons owned warrants for an aggregate of 42,225 shares.
 - (7) On June 13, 2005, the Reporting Persons mistakenly filed a Form 3 reporting a conversion price of \$9.00. As of June 28, 2005, the conversion price is \$5.50.
