- (1) Each share of class B common stock, par value \$0.01, of the issuer (the "Class B Common Stock") is convertible at any time, at the option of the holder, into one share of class A common stock, par value \$0.01, of the issuer (the "Class A Common Stock").
- (2) No expiration.
- (3) On July 18, 2005, and August 1, 2005, the reporting person was granted an aggregate of 210,000 shares of restricted Class B Common Stock. The restricted Class B Common Stock vests upon certain liquidity events if certain performance criteria are met. In connection with the issuer's secondary public offering, on May 31, 2007, 4,882 shares of restricted Class B Common Stock vested due to the exercise of an over-allotment option by the underwriters of the offering.
- (4) Includes 5,406 shares of Class B Common Stock, which will vest on February 22, 2008, if the recipient of such shares continues to be employed by the issuer or any of its subsidiaries at that time.
