Coffeyville Acquisition LLC and Coffeyville Acquisition II LLC each own shares of CVR Energy, Inc. common stock, par value \$0.01 per share ("Common Stock"). Mr. Haugen owns common units equal to 0.03 of each of Coffeyville Acquisition LLC and Coffeyville Acquisition II LLC. Mr. Haugen also owns Acquisition LLC and Coffeyville Acquisition II LLC and (ii) 1,980,952 phantom points pursuant to the Phantom Unit Appreciation Plan (Plan I) and Coffeyville Resources, LLC Phantom Unit Appreciation phantom points constitute rights to a portion of the profits generated by Coffeyville Acquisition LLC II LLC. The phantom unit appreciation plans are filed as exhibits 10.3 and 10.32 to the Comparison File No. 333-137588 (the "Registration Statement"). The limited liability company agreements of Coffeyville Acquisition LLC and Coffeyville Acquisition II LLC are filed as exhibits 10.34 and 10.35, respectively, to the

Mr. Haugen does not have the power to vote or dispose of the shares of Common Stock that are owned by Coffeyville Acquisition LLC and Coffeyville Acquisition II LLC and thus does not have beneficial ownership of the shares of Common Stock. Mr. Haugen does not have any pecuniary interest in the shares of Common Stock held by Coffeyville Acquisition II LLC (or override units or phantom points) because he does not control either Coffeyville Acquisition II LLC and does not have or share investment control over either entity's securities.
