(1) On December 4, 2007, INVESCO PLC effected a redomicile to Bermuda pursuant to a U.K. Scheme of Arrangement under which shareholders received Common Shares in Invesco Ltd., the new Bermuda parent company, in exchange for their Ordinary Shares, par value \$0.10 per share, in INVESCO PLC. Following the redomicile, Invesco Ltd. effected a one-for-two reverse stock split, such that shareholders now hold Common Shares, par value \$0.20 per share.

(2) Shares acquired pursuant to vesting of a Deferred Share Award - Time Vesting, with respect to 333334 Ordinary Shares in INVESCO PLC. Following the redomicile and reverse stock split described in footnote 1, a total of 166667 Common Shares in Invesco Ltd. were acquired.

(3) Deferred Share Award expires upon failure to vest.

(4) Includes 33612 Common Shares subject to a Restricted Share Award previously reported on a separate line on Form 3; also includes 52625 Common Shares held indirectly by spouse.

This Form 4 reports the vesting of certain Deferred Share Awards - Time Vesting on November 30, 2007. As explained in the

hereto, on December 4, 2007, INVESCO PLC effected a redomicile to Bermuda pursuant to a U.K. Scheme of Arrangement under which holders of Ordinary Shares in Invesco Ltd. received Common Shares in Invesco Ltd., the new Bermuda parent company, in exchange for their Ordinary Shares, par value \$0.20 per share, in INVESCO PLC. Following the redomicile, Invesco Ltd. effected a one-for-two reverse stock split, such that shareholders now hold Common Shares, par value \$0.20 per share.
