- Represents 5,047 Restricted Stock Units ("RSUs") that were granted on February 22, 2007, 1,666 of which vested on February 22, 2008 (a non-reportable event) and 3,381 of which have not yet vested. The grant of these RSUs was previously and timely reported in Table II.
