Between January 31, 2009 and January 30, 2010, the reporting person acquired 207.4679 shares of Kroger common stock in the Company's employee benefit plans that are deemed to be 'tax-conditioned plans' pursuant to Rule 16b-3, to the extent disclosed on reports received by plan trustees.
