The restricted stock units vest over three years
- (1) (1/3 on February 11, 2011; 1/3 on January 1, 2012; and 1/3 on January 1, 2013). Of the 34,988 shares of common stock, 11,661 shares were issued on February 11, 2011, of which 5,068 shares were withheld to satisfy payment of the Issuer's tax withholding obligation.
