Following these distributions, neither Ignition Venture Partners nor Ignition Managing Directors holds any shares of common stock of the Issuer.
- (2) The reported shares are represented by restricted stock units which vest in full on the earlier of the day prior to the Issuer's next annual meeting or June 13, 2014.
