(1) On July 10, 2013, Sprint Nextel Corporation ("Old Sprint") merged (the "Merger") with and into a wholly owned subsidiary of Sprint Corporation (the "Issuer"). These shares were acquired in connection with the Merger. Each share of Old Sprint common stock was disposed of for a combination of approximately \$5.65 in cash and 0.2617 share of Issuer common stock, which began trading on the New York Stock Exchange on July 11, 2013.
(2) This excludes Issuer restricted stock units that will be acquired in connection with the Merger. 14,986 Old Sprint restricted stock units will be exchanged for a number of Issuer restricted stock units that is dependent on the trading prices of common stock of the Issuer for the five trading days following the effective time of the Merger (the "Reference Period") and will be promptly disclosed by Issuer once they may be definitely determined.
