The reporting person may also transfer the phantom stock units into alternative investment accounts in certain other instances if applicable ownership guidelines are satisfied.
- (3) The aggregate of 44,477.75 phantom stock units includes: (a) 207.73 phantom stock units acquired through dividend reinvestment in the Harris Corporation Directors' Deferred Compensation Plans ("Plans") on 5/31/17 and (b) a reduction of a .21 phantom stock unit due to rounding of previous reports by the Plans' recordkeeper.
