Pursuant to the instructions in Item 7 of Schedule 13G, Advisory Research, Inc. ("ARI"), 180 N. Stetson, Chicago, IL 60601, a wholly-owned subsidiary of Piper Jaffray Companies and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is the beneficial owner of 7,725,719 shares\* or 13.44% of the Common Stock outstanding of Resolute Energy Corporation ("the Company") as a result of acting as investment adviser to various clients.
