As of the date of this filing, Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), is the beneficial owner of 282,241 shares of the Issuer's Common Stock as it holds 282,241 warrants to purchase the Issuer's Common Stock. Each warrant entitles the holder to purchase one share of Common Stock from the Issuer at an exercise price of \$11.00 per share. The warrants will expire on November 7, 2013, or earlier upon redemption.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. Israel A. Englander ("Mr. Englander"), is the managing member of Millennium Management. Consequently, Mr. Englander may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. The foregoing should not be construed in and of itself as an admission by Millennium Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies.

(b) Percent of Class:

3.7% of the Issuer's Common Stock (see Item 4(a) above), which percentage was calculated based on 7,414,054 shares of Common Stock outstanding following the Issuer's public offering of 5,110,000 shares of Common Stock, as per the Issuer's prospectus dated June 15, 2010.
