- This grant was for 11,000 restricted stock units of the Company, each representing the right to receive one share of the Company's common stock, which will vest in four equal installments on each of September 12, 2012, December 12, 2012, March 12, 2013 and June 12, 2013.
- Following the transactions reported on this Form 4, Mr. Corti held (a) 76,000 shares of the Company's common stock, (b) 11,000 restricted stock units, each representing the right to receive one share of the Company's common stock.
 - These shares are held jointly by Mr. Corti and his spouse, who share voting and investment power with respect thereto.
 - These options will vest with respect to one-fourth of the shares on each of September 12, 2012, December 12, 2012, March 12, 2013 and June 12, 2013.
