The following constitutes Amendment No. 4 to the Schedule 13D filed by the undersigned ("Amendment No. 4"). This Amendment No. 4 amends the Schedule 13D as specifically set forth herein.

Item 4. Purpose of Transaction.

Item 4 is hereby amended to add the following:

On February 24, 2014, the Reporting Persons filed with the Securities and Exchange Commission (the "SEC") a Preliminary Solicitation Statement (the "Preliminary Solicitation Statement") in furtherance of seeking shareholder support to demand that the Issuer call a special meeting of the Issuer's shareholders (the "Special Meeting"). Under Florida law and the Issuer's Bylaws, as amended, the holders of 50% of the Issuer's outstanding shares have the right to demand that the Issuer call a special meeting. If a sufficient number of shareholders support Starboard's efforts to call the Special Meeting, Starboard intends to solicit shareholder support in favor of a non-binding resolution urging the Board of Directors of the Issuer (the "Board") not to approve any agreement or proposed transaction involving a separation or spin-off of the Issuer's Red Lobster business prior to the 2014 Annual Meeting of Shareholders (the "2014 Annual Meeting") unless such agreement or transaction would require shareholder approval.

The Issuer stated in its December 19, 2013 press release that the contemplated Red Lobster separation will not require shareholder approval and that it expects to close the separation transaction in early fiscal 2015, which begins May 26, 2014. It therefore appears that the Issuer intends to complete the Red Lobster separation several months before the 2014 Annual Meeting, which is not expected to be held until September. Starboard believes shareholders deserve a forum for expressing their views on the Issuer's proposed separation of Red Lobster, and Starboard is therefore seeking to call the Special Meeting to give shareholders a platform for expressing their dissatisfaction with the proposed Red Lobster separation before it is too late.

On February 24, 2014, Starboard delivered an open letter to the Issuer's shareholders. In the letter, Starboard informed shareholders that it has filed the Preliminary Solicitation Statement seeking to call a special meeting of the Issuer's shareholders in order to provide shareholders with a democratic forum for expressing their views on the proposed separation of Red Lobster. Starboard also expressed its disappointment that the Board and management continue to ignore shareholders concerns regarding the ill-advised Red Lobster separation and appear to be hurrying to complete a Red Lobster transaction prior to the 2014 Annual Meeting. Starboard further stated in the letter that given management and the Board's track record of poor performance and poor decision-making, together with Starboard's belief that the proposed Red Lobster separation is deeply flawed, Starboard believes it is critical for shareholders in this case to have the right to review and approve any transaction involving Red Lobster that takes place prior to the 2014 Annual Meeting, at which time shareholders will have an opportunity to elect directors whom they believe represent their best interests. In the letter, Starboard also conveyed to shareholders that Starboard is continuing to conduct its own independent analysis of the Issuer's operations and plans to publicly comment in more detail in advance of the Special Meeting, if called, and has begun recruiting highly qualified restaurant operators to advise Starboard as Starboard refines its operating plan for the Issuer. The full text of the letter is attached hereto as Exhibit 99.1 and is incorporated herein by reference.

Item 6. Contracts, Arrangements, Understandings or Relationships With Respect to Securities of the Issuer.

Item 6 is hereby amended to add the following:

On February 24, 2014, the Reporting Persons entered into a Joint Filing and Solicitation Agreement in which, among other things, (a) the Reporting Persons agreed to the joint filing of statements on Schedule 13D with respect to the securities of the Issuer and (b) the Reporting Persons agreed to solicit proxies or written consents to (i) request that the

Issuer call a special meeting of shareholders to approve the Proposals and (ii) approve such Proposals at any special meeting called for such purpose. The Joint Filing and Solicitation Agreement is attached hereto as Exhibit 99.2 and is incorporated herein by reference.
