- (1) The Restricted Stock Units vest over a period of approximately four years, provided certain performance criteria are met.
 - (2) The stock option vests at a rate of 25% per year commencing on September 15, 2015, and 25% on each subsequent anniversary date until 100% vested. The option shares are exercisable as soon as they have vested.
