Item 1.01 Entry Into A Material Definitive Agreement.

On November 22, 2013 and November 27, 2013, Giggles N Hugs, Inc., a Nevada corporation (the "Company"), entered into Subscription Agreements with two accredited investors for the purchase and sale by the Company of \$175,000 of debentures, convertible at \$0.37 per share, with sixty percent (60%) warrant coverage, exercisable at between \$0.25 and \$0.37 per share (the "Units"). The Shares will be eligible for sale pursuant to Rule 144 six (6) months after the date of issue (the "Financing").

These Shares were offered to accredited investors in reliance on an exemption from the registration requirements of the Securities Act of 1933, as amended (the "Securities Act") under Regulation D. The Shares have not been registered under the Securities Act or any state "blue sky" securities laws, and may not be offered or sold absent registration or an applicable exemption from the registration requirements of the Securities Act and applicable state securities laws.
