On November 20, 2017, Magellan Gold Corporation, a Nevada corporation (the "Company), entered into a Letter Agreement with Prospero Silver Corp., a Canadian corporation ("Prospero) allowing the Company to examine and review Prospero's confidential and proprietary information regarding geology, drill hole information and core from the drill holes (the "Data Package") related to the El Dorado prospect.
