(1) Pursuant to terms of the Nonemployee Directors' Deferred Compensation Plan approved by the Board of Directors on February 11, 2000 and amended and restated on April 28, 2006, Mr. Brown elected to receive his 2016 Board of Directors retainer, stock award, and chairman fees in Franklin Electric Co., Inc. common stock, issuance of such shares deferred until he retires or otherwise leaves the Board of Directors (e.g. Stock Units). On May 6, 2016, Mr. Brown was credited with 1,866.25 Stock Units for the annual retainer, 3,265.94 Stock Units for the annual stock award, and 622.09 Stock Units for chairman fees. At distribution, Mr. Brown may elect pursuant to the terms of the Plan to receive his deferred compensation either in shares of Franklin common stock or in cash.
